### P18/08/36 a) Planning Applications to be considered

#### 18/0693/RES Land South of Yaffles

Erection of 5 dwellings, formation and access, footway, parking provision (approval of reserved matters as per 15/0259/OUT granted under appeal).

This application amends the highway access with reduced visibility to the south
