Matters Arising

Colin Pady suggested :-

- that a History Working Group was set up to research the separate development paths of Colyton and Colyford to re-enforce the need for maintaining the physical separation of the two communities.
- the pre-existing Landscape Character Assessment should be utilised in the Neighbourhood plan
- we see if there is a local NP "local champion" that can meet and advise the SG as necessary

Huntley Evans tabled a draft NP overall schedule as a basis for discussion. This was welcomed by the SG, but it was felt that the overall timescale was too compressed. The draft schedule is attached.

CC(P?) pointed out that the NP needed to refer to , and be complementary with, the EDDC local plan. It was suggested that Helen Par should be asked to be the SG's local plan co-coordinator. Proposed Colin Pady, Seconded Natalie McNeice and carried on a show of hands.
